THE HERTFORDSHIRE (TEMPORARY CLOSING OF VARIOUS ROADS IN LITTLE HADHAM, ALBURY AND BISHOPS STORTFORD) ORDER 2022

NOTICE is given that Hertfordshire County Council intends to make an Order under Section 14(1) of the Road Traffic Regulation Act 1984, to prohibit all vehicular traffic from using the following lengths of roads (“the Roads”):-

1. that length of Albury Road, Little Hadham/Clapgate, Albury from its junction with Standon Road north eastwards and north westwards to its junction with Upwick Green, a distance of approximately 1620 metres.

An alternative route will be via Standon Road, A120 (Standon Road/Stortford Road/Kents Lane/Standon Hill), A10 Puckeridge Bypass, B1368 (Buntingford Road/Wickham Hill/ Station Road), Ford Street, The Street, Pelham Road, Braughing Road, Patient End, C35 (unnamed road), C15 (unnamed road), Gravesend Road and Clapgate.

2. that length of Standon Road/Stortford Road, Little Hadham and Hadham Road, Bishops Stortford from its junction with the A120 Standon Road/A120 Little Hadham Bypass roundabout south eastwards to its junction with the A120 Hadham Road/A120 Little Hadham Bypass roundabout, a distance of approximately 3183 metres.

An alternative route will be via A120 Little Hadham Bypass.

3. that length of The Ash/The Ford, Little Hadham from its junction with Standon Road south westwards, south eastwards and south westwards to its junction with C15 (unnamed road), a distance of approximately 2157 metres.

An alternative route will be via Standon Road, Stortford Road, Hadham Road, A120 Hadham Road, A1184 Bishops Park Way, B1004 (Hadham Road/Great Hadham Road/ Winding Hill) and C15 (unnamed road).

The Order is needed because pedestrian crossing improvement works are proposed to be executed on or near the Roads.

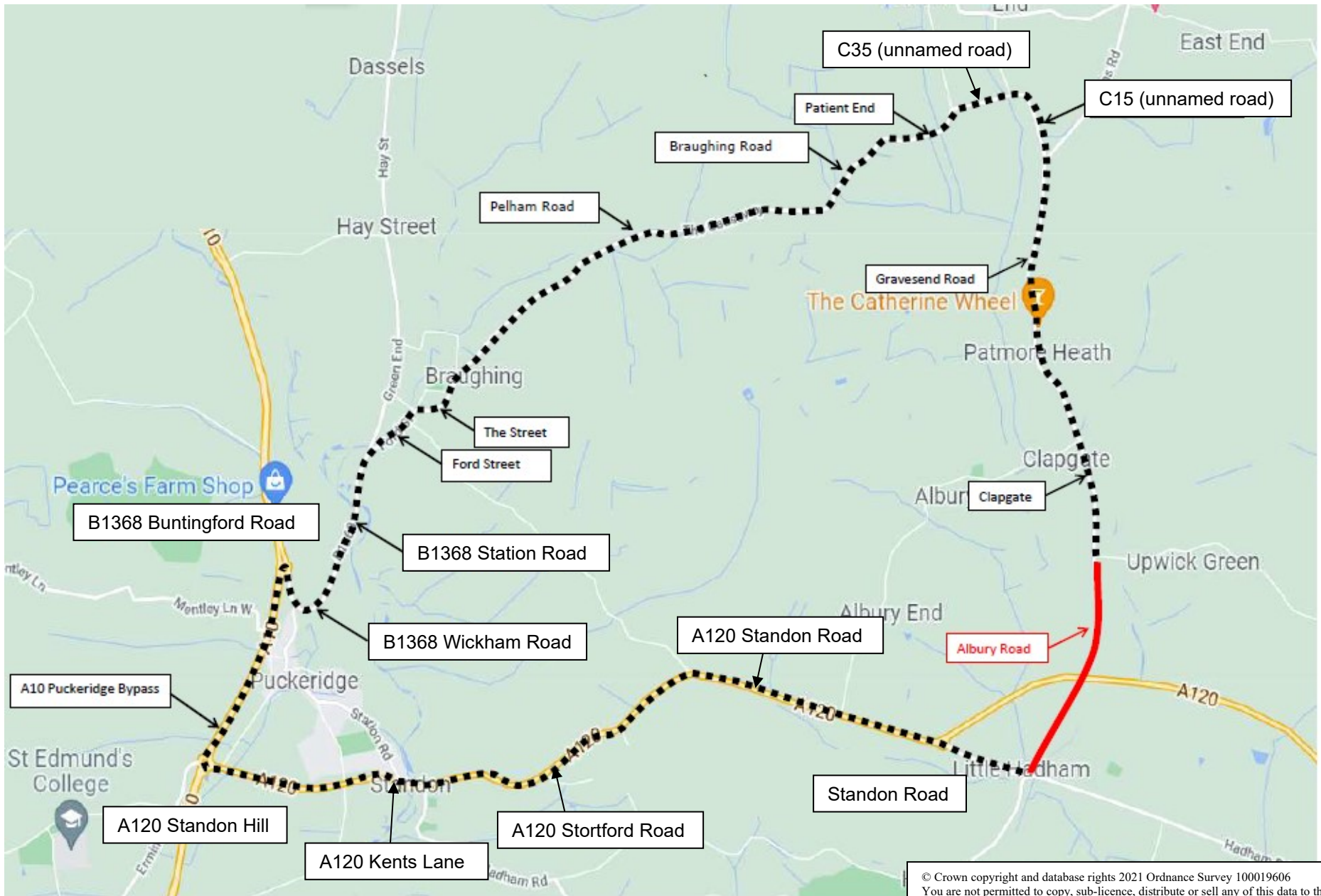
If the Order is made, it shall come into force on 25 April 2022 for a period of up to 18 months. However, the restrictions specified shall only take effect at the times indicated by signs on or near the Roads.

A copy of the proposed Order may be inspected free of charge at County Hall, Hertford between the hours of 9.00am and 5.00pm (excluding weekends, bank and public holidays).

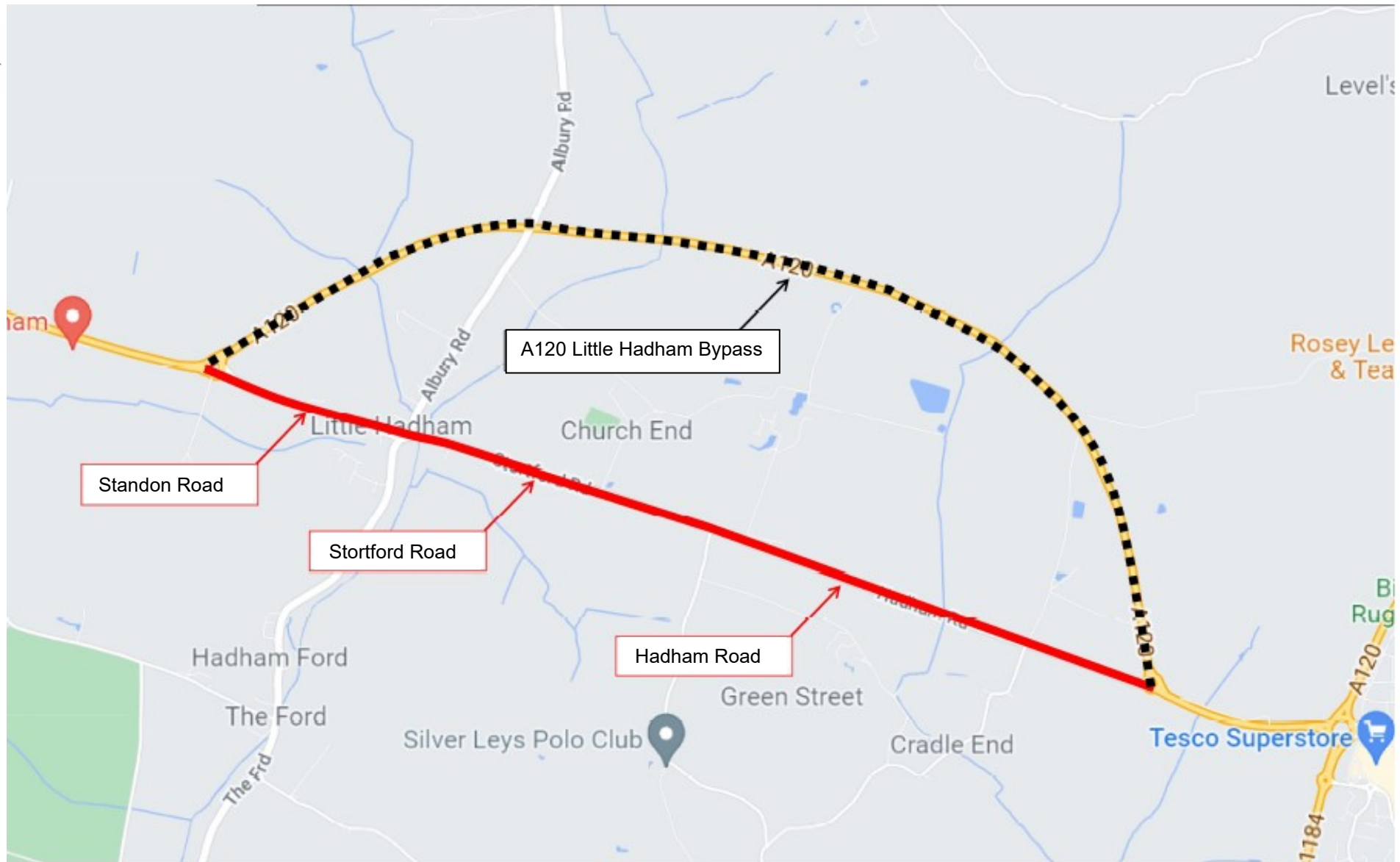

 Albury Road, Little Hadham/Clappgate, Albury



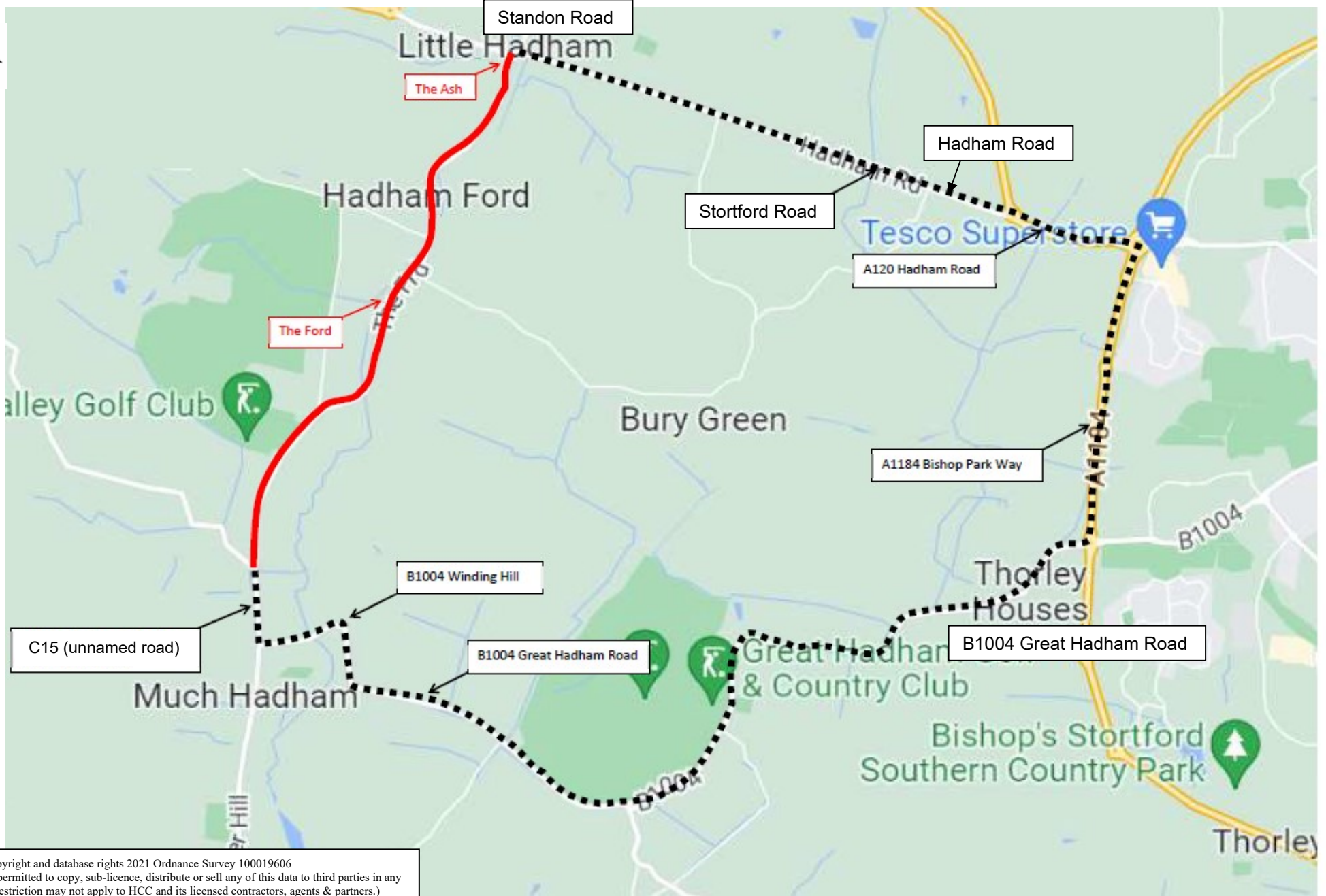
